ENTRY FORMS AND FEES – PROCEDURES

IMPORTANT!!!!!!

CONTEST ENTRIES WILL BE SUBMITTED USING THE ON-LINE ENTRY SYSTEM **UILFORMS.COM** ON THE REGION 25 WEBSITE. **INSTRUCTIONS FOR ENTERING CONTESTS ARE FOUND ON THE “PROCEDURAL CHECKLISTS” (FOR MARCHING CONTESTS, SOLO & ENSEMBLE CONTESTS, AND CONCERT/SIGHTREADING CONTESTS).** These checklists are on the left side of the website under “Enter Contest”.

All evaluation forms will be printed for you – **YOU WILL NOT NEED TO PRINT YOUR JUDGES’ FORMS!**

You may mail or fax your **Form 1** before contest day or bring it to the contest office the day of the contest, but it must be turned in before your group performs.

ENTRY FEES:

- \$330** UIL Marching Band Entry Fee (*includes state fee – one director copy DVD provided at no charge*)
- \$360** 1A/2A/3A/4A/5A Varsity Bands (*includes state fee & recording fee*)
- \$360** HS Full Orchestras (*includes state fee & recording fee*)
- \$345** HS String Orchestras & MS String Orchestras (*includes state fee & recording fee*)
- \$345** MS Bands & Non-Varsity HS Bands (*includes state fee & recording fee*)
- \$335** ALL Choirs (*includes state fee & recording fee*)

Solo & Ensemble

- **Band & String Events: \$12** per solo; **\$8** per each ensemble member (*events scheduled @ 10 minute intervals*)
- **Vocal Events: \$10** per solo; **\$6** per each ensemble member (*events scheduled @8 minute intervals*)

Mr. Video will film the Region Marching Contest in HD with wide angle lens. DVD’s will be sold directly to the public at the contest site. A director copy of your band will be provided to at no charge and will be included in your packet when you check out.

IMPORTANT: Be sure to follow the instructions on the **Mr. Video License Agreement** found on the region website under additional marching forms. Send the Agreement Form directly to Mr. Video.

OFFICIAL DEADLINE DATE: 30 days prior to first day of contest

Cash or personal checks will not be accepted; submit school district checks, cashier’s checks, or money orders only (this includes checks for recording fees when submitted separately.) DISTRICT CONTACT PERSON

If you have a music supervisor in your district, check with him or her for instructions on submitting contest entries/payments. Entry deadlines must be observed. The buffer deadline is for the convenience of the person who may be coordinating entries for an entire district.

CONSTITUTION AND CONTEST RULE BOOK (C&CR) – PRESCRIBED MUSIC LIST (PML)

These publications are available from the State Music Office and also at some music stores. It is advised that every director participating in UIL events secure a copy of each of these publications for reference purposes. **MAKE SURE YOU HAVE A CURRENT COPY OF BOTH PUBLICATIONS.** Order form for music materials/publications can be found on the UIL website at www.uil.utexas.edu. **THE PML IS ALSO AVAILABLE AS PART OF UILFORMS.COM, WHICH IS THE SYSTEM WE USE FOR ALL REGION 25 ON-LINE ENTRIES. THE UIL WEBSITE IS THE OFFICIAL SOURCE FOR ANY AND ALL CORRECTIONS TO THE PML. IT IS YOUR RESPONSIBILITY TO CHECK THIS WEBSITE!** The entire C&CR is also published on the state UIL website, as well as the "TEA/UIL SIDE BY SIDE" document.

PLEASE NOTE: CHANGES IN MUSIC SELECTIONS FOR SOLOS AND ENSEMBLES WILL BE ALLOWED UP TO 7 DAYS PRIOR TO SCHEDULED CONTEST. A LATE FEE OF \$10 PER STUDENT WILL BE ASSESSED FOR ANY LATE ENTRIES PROVIDED THEY ARE IN ADDITION TO ORIGINAL ENTRIES AND DO NOT CAUSE A DISRUPTION TO THE CONTEST DAY.

DIRECTORS MAY MAKE CHANGES ON CONCERT MUSIC UP TO 7 DAYS PRIOR TO SCHEDULED CONTEST. Make your own revisions to your music selections at www.uilforms.com

Remember the importance of becoming familiar with the rules and regulations for the different contests regarding eligibility, music selection, copyright rules, gift-awards rule, etc. Please obtain copies of the Constitution and Contest Rules and the Prescribed Music List.
