

## ENTERING CONCERT & SIGHTREADING CONTESTS

1. Before you can enter contest, you must have registered as a director on [www.uilforms.com](http://www.uilforms.com) or through the Charms Program if you have purchased the program for your school. Be sure to register only once, choosing a user name and password that you will remember. Remember that your name, as the director of a group, will appear on all forms exactly as you type it on your registration. **There is a place to list additional directors of a group when you complete your contest entry form at [www.uilforms.com](http://www.uilforms.com).**
2. Log on to [www.uilforms.com](http://www.uilforms.com) to enter contest. You will click on “**FORM 4**” to submit your entry for C&SR; the sightreading “**FORM 5**” is automatically created when you submit your FORM 4.
3. Region 25 uses the following designations for non-varsity groups: Non-Varsity, Sub Non-Varsity A, Sub Non-Varsity B, Sub Non-Varsity C, etc. If you have questions on how to enter, please call Randy.
4. After submitting your entry (ies), click on “**Review Entries**”; then click “**Print Invoice**”. The system automatically calculates your fees and creates an invoice that you can use as your official paperwork to request payment. **PRINT TWO COPIES – ONE FOR YOUR PAYMENT REQUEST & ONE FOR YOUR RECORDS.** *You do not need to send me a copy of the invoice.*
5. **Entry fees** are as follows:
  - a. Bands:
    - i. HS Varsity Bands - **\$360** per group (*includes state fee and CD recording*)
    - ii. HS NV Bands - **\$345** per group (*includes state fee and CD recording*)
    - iii. MS Bands (Varsity and NV) - **\$345** per group (*includes state fee and CD recording*)
  - b. Choirs:
    - i. All - **\$335** per group (*includes state fee and CD recording*)
  - c. Orchestras:
    - i. HS (full) - **\$360** per group (*includes state fee and CD recording*)
    - ii. HS & MS (string) - **\$345** per group (*includes state fee and CD recording*)
6. **FORM 1** - On the day of the contest, bring 1 copy of the listing all eligible students who will perform.

**THIS FORM SHOULD BE SUBMITTED TO THE CONTEST OFFICE BEFORE YOUR SCHEDULED PERFORMANCE TIME.** Form must be signed by principal. You **may** choose to mail or fax Signed Form 1 prior to contest (972-442-5318).

6. Don't forget to turn in 3 sets of judges' scores with **measures numbered**, to the contest office.
7. **PLEASE MAKE EVERY EFFORT TO SEND ENTRY FEE PAYMENT BY THE CONTEST DEADLINE DATE.**
8. **[Concert Announcer's Script Link](#)** **Please type onto this form before printing and turn in to the contest office when you to arrive.**
